<b>Question</b>	What is the correct course of action in case of changes to financial support agreements in situations where the competent authority has already authorised a group financial support agreement and transmitted it to resolution authorities in accordance with Article 22 Directive 2014/59/EU (BRRD)?
<b>Background on the question</b>	We would appreciate guidance on what to do in situations where a preapproved group financial support agreement has been changed or requires modification.
<b>Final answer</b>	<p>In situations where changes to financial support agreements are carried out, the same procedure should be followed as for the original agreement, including the process outlined in Article 20 BRRD and approval by shareholders outlined in Article 21 BRRD.</p> <p><b>Disclaimer:</b></p> <p>The answers clarify provisions already contained in the applicable legislation.
