²The EBA Decision- 2020/308 does not provide a definition of "Institutional conflict of interest". According to article 1.3.(f) a conflict of interest exists in case of "Employment by a competent authority, which is the named addressee of a proposed EBA measure issued under provisions such as Articles 9b, 16, 17, 18 and 19 of Regulation (EU) No 1093/2010, or which is in the same Member State as such a named addressee." Therefore, under this point only the employment by a competent authority could be relevant.
