9	Time limit for keeping the data	The data is kept for as long as is necessary for the proper functioning of the work of the policy committees, groups, subgroups, task forces and similar bodies. The data contained in the contact lists are regularly reviewed (every six/twelve months). On that occasion, the list of participants to the meeting is also assessed whether there remains a need-to-know basis to keep them or not as for follow-up of the meeting within the next 6/12 months. In the negative, the data are deleted. As soon as the EBA is notified about the changes of the position or personal details of a person, the data in the list are updated, or if no longer necessary, deleted. The email providing this information is kept, until the next verification exercise takes place (once/twice a year)The data is deleted once members and alternates inform the EBA in writing that they no longer form part of the respective policy committees, groups, subgroups, task forces and similar bodies. Inactive emails will be deleted.
