

VACANCY NOTICE

CALL FOR EXPRESSION OF INTEREST FOR **TRAINEES** (TR) AT THE EUROPEAN BANKING AUTHORITY ("THE EBA")

The aim of this vacancy notice is to establish an ongoing pool of interested candidates as the EBA is regularly offering traineeship opportunities for a variety of profiles.

WHAT IS THE TRAINEESHIP ASSIGNMENT?

The traineeship programme is designed to bring recent graduates with diverse backgrounds into the Authority to contribute to various projects and topics in all the services.

The nature of your work depends on the service you are assigned to.

You may, for example work in the field of data analysis, supervisory policy, consumers, law, human resources, communications, Information technologies, etc.

Your daily work may, for example, consist of attending and organising meetings, researching, analysing, drafting and editing various types of documents, supporting the management of projects, etc.

Traineeship at the EBA is offered for an initial period of 6 (six) months and can be extended for a further period of up to 12 (twelve) months, not exceeding a total duration of 18 (eighteen) months. The conditions of the extension are subject to the performance of the trainee and the further needs of the agency.

WHAT ARE THE SELECTION REQUIREMENTS?

Eligibility criteria: to be considered eligible, candidates must satisfy all the criteria listed below when submitting applications:

- Be a national of a Member State of the European Union³ or of the European Economic Area (Iceland, Liechtenstein, Norway).
- Have a thorough knowledge⁴ of English.

HOW TO APPLY?

Candidates should submit their complete applications in English to the following address: EBA-Traineeship-Applications@eba.europa.eu. Only complete applications will be considered.

Please note that candidate must apply to one profile only. Thanks to indicate the preferred profile and Unit in the eligibility criteria grid and your application email.

A complete application must include:

- A curriculum vitae in Europass format;
- A motivation letter non longer than one page;
- A completed eligibility criteria grid;
- Copies of your diplomas (or relevant certificates) of all undergraduate and post-graduate studies declared in the CV (self-certifications are not accepted).

WHAT IS THE SELECTION PROCEDURE?

The ***received applications are screened by HR against the eligibility criteria*** listed in this vacancy notice. Candidates who do not meet all the eligibility criteria are excluded from the selection procedure.

When an opportunity arises, ***eligible applications are provided to the hiring manager*** (Head of Unit/Director of Department) for assessment against the selection criteria listed in the relevant profiles, considering the candidates' preference indicated in the application, their areas of expertise and their competencies.

The ***hiring manager contacts the candidates*** directly, check their availability for an interview, which is held in English and remotely.

⁵ Candidates must have completed their studies and obtained their last education diploma no longer than three years prior the submission of their applications. The 3 years rule is not applicable for candidates undertaking PhD studies at the moment of their application for traineeship at EBA. Only qualifications awarded by EU Member State authorities or European Economic Area (EEA) authorities or qualifications recognised as equivalent by the relevant authorities will be taken into consideration. If the main studies took place outside the European Union, the candidate's qualification must have been recognised by a body delegated officially for the purpose by one of the European Union Members States (such as a national Ministry of Education) or a NARIC recognition is required: <https://www.enic-naric.net/> and a document attesting so must be uploaded with the application. If you have a diploma recognised in an EU Member State, you don't need NARIC recognition for your lower-level diploma(s). Example: If you have a Bachelor's degree from a university outside the EU, and a Master's degree from an EU university, you don't need NARIC recognition for the Bachelor's degree. Qualifications/diplomas awarded until 31/12/2020 in the United Kingdom are accepted without further recognition. For diplomas awarded after this date (from 01/01/2021), a NARIC recognition is required.

The **interview** aims to assess compliance with the selection criteria, motivation, the ability to communicate in English and the availability of the candidate.

HR ensures that a gender and geographical balance is maintained as best as possible in the choice of candidates.

Following the interview, the **Department/Unit makes a recommendation** to the Appointing Authority to Conclude Contracts (AACC) on the candidate(s) based on merit. The AACC makes the **final decision** on whom to offer the traineeship to. **Selected candidates receive a letter of intent** with a traineeship offer that includes a proposed start date for the traineeship. This **traineeship offer is subject to the candidate providing supporting documents** confirming their eligibility, in addition to the already provided diploma or relevant certificates.

Selected candidates must be able to **provide the originals of all diplomas, or certified copies** of all diplomas declared. Candidates whose university or post-graduate diplomas are not issued in one of the official EU languages must provide a certified translation of these documents in English.

Candidates are responsible for ensuring that they have the correct visa, where applicable, and that they obtain all the documentation required by the French authorities.

Candidates may not be recruited to any EBA Department/Unit where a conflict of interest might occur, irrespective of their academic and professional qualifications.

Candidates, who are **not selected after an interview remain in the EBA's pool of interested candidates** for future traineeship opportunities. These candidates will be considered where there is a position to fill that fits their profile and the EBA's business needs and budgetary situation. Candidates **will remain in the pool of eligible trainees for 1 year after the submission of their applications**.

At any stage of the application process, candidates may withdraw their application by informing the Authority by email. Such notification is to be sent to the email address stated in the relevant vacancy notice published on the EBA's website.

EBA ensures that candidates' personal data is processed as required by Regulation (EU) 2018/1725⁶.

There is no appeal procedure against the decision taken.
