## Minutes of the ad hoc meeting on 17 December 2025

### **Agenda item 1: Welcome, approval of the agenda and Pre-selection Board's conclusions**

1. The EBA Vice-Chairperson welcomed the participants. He informed that only the Board of Supervisors (BoS) Voting Members and their Alternates were present. He reminded them of the conflict-of-interest policy requirements and asked them whether any of them considered themselves as being in a conflict. No Member declared a conflict of interest.
2. The Vice-Chairperson noted that the aim of the meeting was to interview the pre-shortlisted candidates as proposed by the Pre-Selection Board for the position of the EBA Chairperson. The objective was to come up with the shortlist of candidates to send to the European Parliament and the Council of the European Union. He noted the swift process with a vacancy launched in October and closed in November 2025. He thanked the Pre-Selection Board for their availability and, as well as EBA staff.
3. A member of the Pre-Selection Board provided the feedback of the Pre-Selection Board based on their report. The BoS discussed matters arising from the report and lessons learned.
4. The EBA Ethics Officer summarised information on potential conflicts of interest, independence and any matters which could affect suitability of the candidates for the role as provided by the pre-shortlisted candidates.
5. The Vice-Chairperson outlined the plan for interviews and shortlisting.
6. The Vice-Chairperson asked the Members whether there were any comments on the draft agenda. There were no comments on the agenda.

7. The BoS approved the agenda of the meeting by consensus.
