### WHAT IS THE EBA?

The EBA is an independent European Union Authority established on 1 January 2011 by Regulation (EU) No. 1093/2010 of the European Parliament and of the Council of 24 November 2010<sup>2</sup>.

With a view to improving the functioning of the European Union internal market, the EBA works to ensure a high quality, effective and consistent level of regulation and supervision in its areas of competence. It also promotes public values such as the stability of the financial system, the transparency of markets and financial products, and the protection of depositors and investors.

It works to prevent regulatory arbitrage and guarantee a level playing field, strengthens international supervisory coordination, promotes supervisory convergence, and provides advice to the Union institutions in the areas of banking, payments and e-money regulation and supervision and related corporate governance, auditing and financial reporting issues.

As an integral part of the European System of Financial Supervision (ESFS), the EBA works closely together with its sister authorities, the European Insurance and Occupational Pensions Authority (EIOPA) and the European Securities Market Authorities (ESMA), as well as the Joint Committee and the European Systemic Risk Board (ESRB).

## WHAT IS THE JOB ON OFFER?

### Main purpose

As a member of the Data Analytics, Reporting and Transparency (DART) Department and Statistics (STATS) Unit, the Statistician will report to the Head of STATS Unit. The Statistician will be working on the development and maintenance of the EBA's databases of supervisory data as well as of risk assessment tools and dashboards. In addition, he/she will undertake empirical analyses on the EU banking sector, including stress testing.

### Main responsibilities

- To contribute to the management of EBA's database and registers, and to the implementation and testing of end-user ICT solutions;
- To improve the EBA's data input to its risk assessment and dashboard;
- To participate in the preparation of reports with statistical analyses using state-of-the-art statistical techniques;
- To coordinate surveys and data collections, developing processes for checking the accuracy, consistency and comparability of the data;
- To support the EBA's data hub role by designing and maintaining innovative ways of sharing confidential and non-confidential data with the EBA's stakeholders;
- To contribute to the EBA's other activities, including impact assessment, benchmarking of internal models and stress testing, monitoring of data regarding EU's AML/CFT policies;
- To execute any other tasks as decided by and under the responsibility of the Director of DART Department and/or the Head of STATS Unit.

Furthermore, you will be joining the EBA at an exciting time as the Authority expanded its mandate with the implementation of the European Markets in Crypto-Assets Regulation (MiCA) and the EU Digital Operational Resilience Act (DORA).

You will live in Paris. The French capital is one of the most inspiring cities in Europe. Your contract will be for a duration of 3 years and can be extended for an additional 3 years. Any further extension would be indefinite.

You will benefit from work-life balance with teleworking flexibility, learning and development opportunities such as language trainings, social integration as well as free access for children to the [European school](#) facilities.

## WHAT ARE THE SELECTION REQUIREMENTS?

Applications will be assessed based on the Eligibility and Selection criteria specified in this vacancy notice.

### Eligibility criteria

To be considered eligible, candidates must satisfy all the criteria listed below by the deadline for submitting applications:

#### General

- Be a national of a Member State of the European Union<sup>3</sup> or Iceland, Liechtenstein, Norway<sup>4</sup>;
- Be entitled to your full rights as a citizen<sup>5</sup>;
- Have fulfilled any obligation imposed by applicable laws on military service;
- Have a thorough knowledge<sup>6</sup> of English<sup>7</sup> and a satisfactory knowledge<sup>8</sup> of another official language<sup>9</sup> <sup>10</sup> of the European Union;
- Have the appropriate character references as to your suitability for the performance of your duties;
- Be physically fit to perform the duties linked to the post<sup>11</sup>.

#### Qualifications<sup>12</sup>

Candidates must have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

### Selection criteria

In addition to the eligibility criteria above, the following selection criteria will be used. **Candidates are required to clearly indicate in their CVs how they acquired the knowledge and experience allowing them to meet the selection criteria mentioned below and to give specific examples.**

#### Essential technical competencies criteria (to be mainly assessed in the application):

- At least 1 year of fulltime professional experience in one or more of the following areas:
  - Managing data collections, including data modelling and data management;
  - Developing business intelligence and data visualisations tools;
  - Supervision of financial institutions through the calculation and monitoring of risk indicators based on supervisory data.

- Experience in using one or more statistical software packages, such as Statistical Analysis Software (SAS), R or Stata, with a preference for SAS;
- Knowledge gained through professional experience or studies of one or more programming languages, such as Visual Basic for Applications (VBA), Python, or Matlab, with a preference for VBA.

#### **Advantageous technical competencies criteria** (to be mainly assessed in the application):

Candidates who meet all the essential technical competencies criteria will be scored against the advantageous technical competencies criteria:

- Experience in an EU/multicultural/international/EU institutions' working environment;
- Proven knowledge and experience in banking supervision;
- Proven knowledge and experience in analysis of the banking sector.

#### **Behavioural competencies criteria** (to be mainly assessed during the interview/written test):

- Drive for results with flexibility to take on new tasks in a dynamic and fast-paced working environment;
- Communicate clearly and precisely both orally and writing;
- Act in line with EU high-standard professional values (such as ethics and integrity, respect, open collaboration, etc);
- Ability to work co-operatively with others, within the team and across organisational boundaries.

## **HOW TO APPLY?**

#### A complete application must include:

- A curriculum vitae in Europass format<sup>14</sup>;
- A motivation letter;
- A completed eligibility criteria grid;
- If applicable, a copy of your diploma's equivalence certificate, issued by an EU Member State (see footnote for Qualifications).

The EBA will disregard any application received after deadline. Candidates are strongly advised not to wait until the last day to submit their applications, since heavy internet traffic or internet connection issues could lead to difficulties in submission. The EBA cannot be held responsible for any delay due to such difficulties.

Professional experience indicated on the curriculum vitae is only counted from the date the candidate obtained the certificate or diploma required for the position and if it is on a paid basis (including study grants or internship grants).

The exact start and end dates of all professional experience (in the format of "dd/mm/yyyy") and whether it was full time or part time work must be clearly indicated on the curriculum vitae. Freelance or self-employed candidates must provide either a copy of the entry in the relevant trade register, or any official document (for example a tax return document) clearly showing the length of the relevant professional experience. Details of any professional experience, training, research or studies must be given on the application form. Candidates must be able to provide supporting documents clearly showing the duration and nature of their

professional experience upon request. PhDs may be counted as professional experience if the candidate received a study grant or salary during the period of the PhD studies. The maximum duration counted for a PhD is three years provided that the PhD has been successfully concluded by the closing date for applications of the selection procedure.

The address indicated on the curriculum vitae will be recognised as proof of residence to be used for defining travel reimbursements, etc (if applicable).

## WHAT IS THE SELECTION PROCEDURE?

A **Selection Board**<sup>15</sup> will be established to assess the application documents (curriculum vitae, motivation letter, and eligibility criteria grid) of applicants with reference to the eligibility and selection criteria and to establish the final reserve list.

Candidates who do not meet all the eligibility criteria will be excluded from the selection procedure. Eligible candidates will then be scored on the essential technical competencies criteria. Those who meet all the essential technical competencies criteria will be scored against the advantageous technical competencies criteria. Those candidates who do not meet all the essential technical competencies criteria will not be assessed further.

The Selection Board will invite the shortlisted candidates (maximum of 10)<sup>16</sup>, who best correspond to the profile sought and on condition that they have achieved a score of at least 60% during the evaluation of applications, to the written test phase. Following the written test, all candidates who score the minimum of 60% of the total score, will be invited to the interview with the Selection Board. Interviews and written tests may be held remotely. Shortlisted candidates will be asked to provide supporting documents proving their eligibility before the interview and written test phase.

After the evaluation of interviews and written tests, the Selection Board will draw up a list of the most suitable candidates ("reserve list") to be proposed to the Appointing Authority. Only candidates who receive at least 60% of the maximum points at the interview and written test phase will be included in the reserve list that the Appointing Authority will decide to adopt.

Successful candidates who are placed on the reserve list will be informed accordingly. The successful candidate will be selected from the established reserve list which may also be used for the recruitment of a similar position depending on the needs of the EBA. When a vacancy becomes available, candidates on the reserve list may be contacted for additional interviews. It should be noted that inclusion on the reserve list does not imply entitlement to employment in the Agency.

In accordance with Articles 11 and 11a of the Staff Regulations (SR) and Articles 11 and 81 of the Conditions of Employment of Other Servants of the European Union (CEOS) the successful candidate will be required to make a **declaration of any conflict of interest before recruitment**. The EBA's Executive Director will examine whether the successful candidate has any personal interest which may impair his/her independence or any other conflict of interest in relation to the position offered and will adopt appropriate measures. To that end, the successful candidate shall inform the Executive Director of any actual or potential conflict of interest using a specific form.
