The Authority

The European Banking Authority ("EBA") is an independent European Union Authority established on 1 January 2011 by Regulation (EU) No. 1093/2010 of the European Parliament and of the Council of 24 November 2010.²

The Mission

With a view to improving the functioning of the European Union internal market, the EBA contributes to ensuring a high quality, effective and consistent level of regulation and supervision in its areas of competence. It also promotes public values such as the stability of the financial system, the transparency of markets and financial products, and the protection of depositors and investors.

It works to prevent regulatory arbitrage and guarantee a level playing field, strengthens international supervisory coordination, promotes supervisory convergence and provides advice to the Union institutions in the areas of banking, payments and e-money regulation and supervision, and related corporate governance, auditing and financial reporting issues.

As an integral part of the European System of Financial Supervision (ESFS), the EBA works closely together with her sister authorities, the European Insurance and Occupational Pensions Authority (EIOPA) and the European Securities Market Authorities (ESMA), as well as the Joint Committee and the European Systemic Risk Board (ESRB).

The EBA is seeking a suitable candidate for the position of IT Operations Specialist at its offices in London, United Kingdom. The IT Operations Specialist will play an important role in operating and supporting the IT applications and backend infrastructure used by the EBA and the National Competent Authorities.

Job description

Main purpose

The IT Operations Specialist will contribute to operating the IT solutions in the test and production environment. S/he will also contribute to the design and drafting policies and standards in the area of IT production operations and in relation to the regulations of the European Commission.

Main responsibilities:

- Monitoring and operating the end to end business solution;
- System issue identification and resolution by applying known first-line fixes;
- Analysing and documenting issues that cannot be fixed at first level for escalation to second line;
- Communicating with both internal and external customers in a professional manner to resolve issues:
- Staying up to date with system and solution developments/changes;
- Taking proactive measures to address faults and document actions taken;
- Performing technical system checks and shift readiness reports;
- Performing shift handovers as required from engineer to engineer;
- Ensure that the incident ticketing system is regularly checked for high or critical priority tickets that need escalating to on call teams;
- Maintaining a professional composure whilst system issues are occurring;
- Ensuring issues with processes are flagged to the manager;
- Ensuring that issues with toolsets are flagged to the manager;
- Ensuring that operating or processing risks are flagged to the manager;
- Operating the user security on application backend;
- Coordinating Change Control migration process through non-Production and Production environments according to policies and procedures.

The EBA IT Team is small and requires sharing of tasks amongst its members. Shared tasks include for example:

- Contributing to drafting technical specifications for tender procedures and participating in the evaluation;
- Contributing to the planning of maintenance activities in particular related to the EBA's backend environment;
- Purchasing of hardware and software from existing framework contracts of the European Banking Authority;



Contributing to drafting and validating technical designs in particular for the EBA's IT infrastructure and backend systems (i.e. Unix, Oracle RDBMS, Microsoft SQL Server, Oracle Weblogic etc.).

Requirements

1. Eligibility Criteria

To be considered eligible, candidates must satisfy all the criteria listed below, by the deadline for submitting applications.

1.1 General

- Be a national of a Member State of the European Union, or a national of the European Economic Area (Iceland, Liechtenstein, Norway);
- Be entitled to his/her full rights as a citizen;³
- Have fulfilled any obligations imposed by the applicable laws on military service;
- Have a thorough knowledge of one of the official languages of the European Union⁴ and a satisfactory knowledge of another language of the European Union;
- Be physically fit to perform the duties linked to the post.⁵

1.2 Specific

1.2.1 Qualifications

To be eligible, a candidate must have a level of education which corresponds to completed university studies of at least three years attested by a diploma⁶ and appropriate professional experience of at least one year.

1.2.2 Professional experience

To qualify for the position, a candidate must have, in addition to the above, at least 6 years of relevant proven fulltime professional experience in the field of IT of which at least 4 years in a comparable position after completing the education as mentioned under 1.2.1.

1.2.3 Knowledge of languages

For working purposes, as English is the working language of the EBA,⁷ an excellent knowledge of the English language, both written and spoken, is required.⁸

Native English speakers will be tested to prove their second language skills, in accordance with section 1.1.

2. Selection criteria

In addition to the above, the following selection criteria will be used:

- Experience in working as a production operator for a significant backend system;
- Experience in working together with external IT providers in the second and third line support;
- Good knowledge of UNIX/Linux
- Good knowledge of Microsoft SQL Server and Oracle RDBMS
- General understanding of encryption technologies;
- Good knowledge of computer networking and network protocols, such as FTP, telnet, HTTP(S), and SSH;
- Sound knowledge of ITIL in particular related to incident and problem management;

Applications will be assessed on the basis of the Eligibility and Selection criteria specified in parts 1 and 2.

For this position the candidates are expected to fulfil the following competencies to be assessed during interviews:

- Excellent problem solving skills and the ability to determine the most appropriate solution to an identified incident or problem;
- Excellent communication skills with customers across all levels of the Organisation;
- Strong orientation to results and the ability to meet agreed deadlines and targets under time pressure;
- Ability to independently organise a number of parallel activities (conceptual tasks, incidents, problems, service requests) and follow through until their completion;
- Ability to promote innovative ideas for the improvement of the EBA IT Operations;
- Flexibility in taking over other tasks in view of a dynamic and evolving institutional environment.

3. Equal opportunities

As a European Union Authority, the EBA will apply a policy of equal opportunities and will take care to avoid any form of discrimination in its recruitment procedures.

4. Selection procedure

The selection procedure will include the following:

- 4.1. The selection committee will be established. All the candidates invited to interviews shall be informed on the composition of the selection committee in the invitation to the interview.
- 4.2. The selection committee will analyse application documents (curriculum vitae, motivation letter, and eligibility criteria grid) of applicants with reference to the eligibility and selection criteria and will establish a shortlist. Short listed candidates may be invited to sit written tests and interviews.

Written tests will be done in English and will be related to the job and designed to test the ability to communicate in written English, knowledge and competencies related to the job, and drafting skills. Total mark for written test: 10. The minimum score to pass: 6.

The interview will aim to assess the suitability of the candidate to perform the duties, professional knowledge and motivation. The interview will be held in English. Total mark for interview: 10. The minimum score to pass: 6.

Successful candidates with the total score equal to and above 12 will be placed on the reserve list, which will be valid until **31 December 2017.** It may be renewed. Inclusion in the reserve list does not guarantee recruitment. The successful candidate will be selected from the established reserve list which may also be used for the recruitment of a similar post depending on the needs of the EBA.

In accordance with Articles 11 and 11a of the Staff Regulations (SR) and Articles 11 and 81 of the Conditions of Employment of Other Servants of the European Union (CEOS) the successful candidate will be required to make a declaration of the conflict of interest before recruitment. The EBA's Executive Director will examine whether the successful candidate has any personal interest which may impair his/her independence or any other conflict of interest in relation to the position offered and will adopt appropriate measures. To that end, the successful candidate, using a specific form shall inform the Executive Director of any actual or potential conflict of interest.

Please note that the selection committee's work and deliberations are strictly confidential and that any contact with its members is strictly forbidden. Any contact made by the candidates or third parties in order to influence the members of the selection committee in relation to the selection constitutes grounds for disqualification from the selection procedure.

5. Appointment and conditions of employment

5.1 Contract type, duration and starting date:

The successful candidate will be offered a contract agent⁹ fixed-term contract of three years with a probation period of nine months and the possibility of extension.

The estimated starting date is **1 June 2017**.

5.2 Function group and grade:

The successful candidates shall be recruited as a contract agent in function group IV. The estimated monthly basic salary is from € 3,353.84.

Example: A contract agent with experience of less than 8 years (recruited at grade 13 of FG IV), marital status - single, entitled to expatriation allowance earns an estimated monthly <u>net salary</u> of € 4,642.65 (£ 3,832.51).

5.3 Summary of the conditions of employment

- Salaries are exempted from national tax; instead a Union tax at source is paid;
- The correction coefficient applicable to the remuneration of officials and other servants under Article 64 of the Staff Regulations for the United Kingdom shall apply;
- Depending on the individual family situation and the place of origin, staff members may be entitled to the following: expatriation allowance, household allowance, dependent child allowance, education allowance, installation allowance and reimbursement of removal costs, initial temporary daily subsistence allowance, and other benefits;
- Annual leave entitlement two days per calendar month plus additional days for age, grade, and
 2.5 days of supplementary home leave granted to staff entitled to the expatriation allowance or foreign residence allowance;
- EU Pension Scheme (after 10 years of service);
- EU Joint Sickness and Insurance Scheme, accident and occupational disease insurance coverage, unemployment and invalidity allowance;
- Travel insurance when travelling on missions.

5.4 Place of employment

6. Submission of Applications

Applications including a curriculum vitae in the Europass format,¹⁰ a motivation letter, and a filled eligibility criteria grid, dated and signed before the deadline should be submitted in English to the following address: vacancies@eba.europa.eu by 30 March 2017 at 12.00 noon London time.

EBA will disregard any application received after deadline. Applicants are strongly advised not to wait until the last day to submit their applications, since heavy internet traffic or fault with the internet

connection could lead to difficulties in submission. The EBA cannot be held responsible for any delay due to such difficulties.

Only complete applications will be accepted and considered. In order for the application to be considered complete candidates must send all documents: curriculum vitae in the Europass format, motivation letter, and eligibility criteria grid dated and signed before the deadline.

Candidates should assess and check before submitting their application whether they fulfil all the requirements as specified in the vacancy notice, particularly in terms of qualifications and relevant professional experience.

Professional experience indicated in the curriculum vitae are counted only from the time the candidate obtained the certificate or diploma required for the position and if it is on paid basis (including study grants or internship grants). PhDs may be counted as professional experience if the candidates received a study grant or salary during the time of PhD studies. The maximum duration counted for PhD is three years provided that the PhD has been successfully concluded by the closing date for applications of the selection procedure.

Start and end dates of all previous positions and whether full time or part time work should be indicated in the curriculum vitae. Freelance or self-employed candidates must provide either a copy of the entry in the relevant trade register, or any official document (for example a tax return document) showing clearly the length of the relevant professional experience. Details of any professional experience, training, research or studies must be given on the application form. Candidates must be able to provide photocopies of supporting documents clearly showing duration and nature of experience upon request.

The address indicated in the curriculum vitae will be used as the location from which the candidates invited to interviews travel.

At this stage, please do not send supporting documents (copies of ID cards, passports, diplomas, etc.)

7. Data protection

EBA will ensure that candidates' personal data are processed as required by Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to processing of personal data by the Community institutions and bodies and on the free movement of such data. This applies in particular to the confidentiality and security of such data.

8. Appeal Procedure

Candidates who consider that their interests have been prejudiced by any decision related to the selection procedure can take the following actions:



Request for review of the decisions taken by the Selection Committee
