The Authority

The European Banking Authority ("EBA") is an independent European Union Authority established on 1 January 2011 by Regulation (EU) No. 1093/2010 of the European Parliament and of the Council of 24 November 2010.¹

The Mission

With a view to improving the functioning of the European Union internal market, the EBA contributes to ensuring a high quality, effective and consistent level of regulation and supervision in its areas of competence. It also promotes public values such as the stability of the financial system, the transparency of markets and financial products, and the protection of depositors and investors.

It works to prevent regulatory arbitrage and guarantee a level playing field, strengthens international supervisory coordination, promotes supervisory convergence and provides advice to the Union institutions in the areas of banking, payments and e-money regulation and supervision, and related corporate governance, auditing and financial reporting issues.

As an integral part of the European System of Financial Supervision (ESFS), the EBA works closely together with her sister authorities, the European Insurance and Occupational Pensions Authority (EIOPA) and the European Securities Market Authorities (ESMA), as well as the Joint Committee and the European Systemic Risk Board (ESRB).

The EBA is seeking a suitable candidate for the position of a **Policy Expert on secondment**² in the Supervisory Review, Recovery and Resolution Unit of the Prudential Regulation and Supervisory Policy Department of the EBA at its offices in Paris, France.

Job description

Main purpose

Under the responsibility of the Head of the Supervisory Review, Recovery and Resolution Unit, the Policy Expert will contribute to the EBA's work on supervisory review, assessment of risks, capital and liquidity adequacy under the Pillar 2 framework in ensuring that regulatory and supervisory rules for on-going concern and crisis situations are implemented consistently across the EU, in particular through the development of technical standards, guidelines, opinions and reports, through the monitoring of the consistent implementation of the Single Rulebook and through the monitoring of supervisory and resolution colleges.

The role will also involve advising, monitoring and facilitating competent authorities in the implementation and application of guidelines and standards in a consistent way in day-to-day supervisory practices.

Main responsibilities:

- Contributing to the development of EBA policies and methodologies under the Pillar 2 framework as well as advising, monitoring and facilitating their implementation in a comparable and consistent manner across the EU;
- Participating in the development and taking responsibility for timely completion of guidelines, binding technical standards or any other regulatory products relevant for supervisory review, assessment of risks, capital and liquidity adequacy under Pillar 2;
- Providing policy advice and contributing to the preparation of policy stances related to supervisory
 and resolution issues and in particular in relation to the assessment of risks, capital and liquidity
 adequacy under Pillar 2 and the overall supervisory review and evaluation process;
- Contributing to the monitoring of supervisory and resolution colleges, through the participation colleges of cross-border banking groups;
- Providing support to the EBA internal committees and subgroups and their chairpersons;
- Liaising with external stakeholders such as competent and resolution authorities, EU institutions, agencies and bodies;
- Providing implementation advice and guidance related to relevant EBA policies including the provision of training;
- To the extent necessary, externally representing the EBA at a technical level in his/her area of expertise;
- Executing other related tasks as sought by the Head of the Unit, as for instance tasks related to resolution topics.

Requirements

1. Eligibility Criteria

To be considered eligible, candidates must satisfy all the criteria listed below, by the deadline for submitting applications:

1.1 General

- Be a national of a Member State of the European Union, of an European Free Trade Association Member State (Iceland, Liechtenstein, Norway, and Switzerland), or a country with which the Council has decided to open accession negotiations and which has concluded a specific agreement on staff secondments;
- Be entitled to his/her full rights as a citizen;
- Have a thorough knowledge of one of the official languages of the European Union³ and a satisfactory knowledge of another language of the European Union;
- Be employed by a) a member of the ESFS (as specified in Article 2 of Regulation (EU) no. 1093/2010), b) a country with which the Council has decided to open accession negotiations and which has concluded a specific agreement on staff secondments for participation in EBA's work within the meaning of Article 75 of the Regulation, c) a public intergovernmental organisation, who are seconded to EBA so that it can use their expertise in a particular field.⁴
- Have worked for their employer on a permanent or contract basis for at least 12 months before their secondment.
- Have the support to apply for this position, evidenced by a letter of support from the applicant's employer (as defined in the fourth bullet point).

1.2 Specific

1.2.1 Qualifications

To be eligible, a candidate must have a level of education which corresponds to completed university studies of at least three years attested by a diploma.⁵

1.2.2 Professional experience

To qualify for the position a candidate must have, in addition to the above, at least 6 years of relevant proven fulltime professional experience, of which at least 3 years must have been in the field of banking supervision (on or off-site), banking resolution, prudential risk management or prudential risk reporting after completing the education as mentioned under 1.2.1.

1.2.3 Knowledge of languages

For working purposes, as English is the working language of the EBA⁶, an excellent knowledge of the English language, both written and spoken, is required.⁷

Native English speakers will be tested to prove their second language skills.

2. Selection criteria

In addition to the above, the following selection criteria will be used:

- Proven experience in assessing or reporting prudential risks and/or own funds of banks;
- Proven knowledge of EU banking regulation, in particular in relation to the supervision and/or resolution of cross-border banks;
- Proven experience of supervisory and/or resolution colleges;
- Proven experience in drafting supervisory and/or resolution policies, stances, procedures or reports;
- Proven experience of dealing with a wide range of stakeholders.

Applications will be assessed on the basis of the Eligibility and Selection criteria specified in parts 1 and 2.

For this position, the candidates are expected to fulfil the following competencies to be assessed during interviews:

- Be able to investigate and analyse complex information from a wide range of sources, consider options and propose and implement effective solutions to challenging legal and practical issues;
- Be able to take initiative and to work autonomously;
- Be able to communicate legal issues effectively to policy and operational colleagues;
- Strong sense of responsibility, commitment and cooperation;
- Flexibility to take on new tasks in a dynamic and evolving institutional environment;
- Proactive attitude;
- Ability to work efficiently under pressure.

3. Equal opportunities

As a European Union Authority, the EBA will apply a policy of equal opportunities and will take care to avoid any form of discrimination in its recruitment procedures.

4. Selection procedure

The selection procedure will include the following:

- 4.1. The selection committee will be established. All the candidates invited to interviews shall be informed on the composition of the selection committee in the invitation to the interview.
- 4.2. The selection committee will analyse application documents (CV, motivation letter, and eligibility criteria grid, statement of the employer supporting the application) of applicants with reference to the eligibility and selection criteria and will establish a shortlist. Short listed candidates may be invited to sit written tests and interviews.

Written tests will be done in English and will be related to the job and designed to test the ability to communicate in written English, knowledge and competencies related to the job, and drafting skills. Total mark for written test: 10. The minimum score to pass: 6.

The interview will aim to assess the suitability of the candidate to perform the duties, professional knowledge and motivation. The interview will be held in English. Total mark for interview: 10. The minimum score to pass: 6.

Successful candidates with the total score equal to and above 12 will be placed on the reserve list, which will be valid until **31 December 2020**. It may be renewed. Inclusion in the reserve list does not guarantee recruitment. The successful candidate will be selected from the established reserve list which may also be used for the recruitment of a similar post depending on the needs of the EBA.

The selection committee's work and deliberations are strictly confidential and any contact with its members is strictly forbidden. Any contact made by the candidates or third parties in order to influence the members of the selection committee in relation to the selection constitutes grounds for disqualification from the selection procedure.

5. Appointment and conditions of secondment

5.1 Contract type, duration and starting date:

The successful candidate will be offered the position of Seconded National Expert for a minimum period of 12 months with the possibility of extension.

The estimated starting date is **1 October 2019**.

5.2 Conditions of secondment

The person to be seconded shall remain in the service of his/her employer throughout the period of secondment. The SNE's employer shall thus undertake to continue to pay the salary, to maintain the social rights, particularly social security and pension.

In accordance with the EBA Decision on secondment of national experts, an SNE shall be entitled to a daily subsistence allowance and a monthly subsistence allowance (established by the Commission each year) paid by the EBA throughout the period of secondment. The allowances are intended to cover SNE's living expenses in the place of secondment on a flat-rate basis and shall in no circumstances be construed as remuneration paid by EBA.



These allowances are subject to the exchange rate as published monthly by the European Commission and the country correction coefficient currently applicable for Paris, France (116.7 %).

5.3 Place of secondment

The offices of the European Banking Authority will be located on Floors 24 to 27, Europlaza, 20 Avenue André Prothin, La Défense 4 – 92400 Courbevoie, France.

6. Submission of Applications

Applications including a curriculum vitae in the Europass format⁸, a motivation letter, and a filled eligibility criteria grid, dated and signed, and a statement of the employer issued by the applicant's employer, (as defined in 1.1. fourth bullet point) supporting his/her application for a position on secondment, should be submitted in English to the following address: EBA-Applications@eba.europa.eu by 15 August 2019 at 12:00 noon Paris time.

EBA will disregard any application received after deadline. Applicants are strongly advised not to wait until the last day to submit their applications, since heavy internet traffic or fault with the internet connection could lead to difficulties in submission. The EBA cannot be held responsible for any delay due to such difficulties.

Only complete applications will be accepted and considered. In order for the application to be considered complete candidates must send all documents: curriculum vitae in the Europass format, motivation letter, eligibility criteria grid dated and signed, and a statement of the employer issued by the applicant's employer (as defined in 1.1. fourth bullet point) supporting his/her application for a position on secondment before the deadline.

Candidates should assess and check before submitting their application whether they fulfil all the requirements as specified in the vacancy notice, particularly in terms of qualifications and relevant professional experience.

Professional experience indicated in the curriculum vitae are counted only from the time the candidate obtained the certificate or diploma required for the position and if it is on paid basis (including study grants or internship grants). PhDs may be counted as professional experience if the candidates received a study grant or salary during the time of PhD studies. The maximum duration counted for PhD is three years provided that the PhD has been successfully concluded by the closing date for applications of the selection procedure.

Start and end dates of all previous positions and whether full time or part time work should be indicated in the curriculum vitae. Freelance or self-employed candidates must provide either a copy of the entry in the relevant trade register, or any official document (for example a tax return document) showing clearly the length of the relevant professional experience. Details of any professional experience, training, research or studies must be given on the application form. Candidates must be

able to provide supporting documents clearly showing duration and nature of experience upon request.

The address indicated in the curriculum vitae will be used as the location from which the candidates invited to interviews travel.

At this stage, please do not send supporting documents (copies of ID cards, passports, diplomas, etc.).

7. Data protection

EBA will ensure that candidates' personal data are processed as required by Regulation (EU) 2018/1725 of the European Parliament and the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC⁹

8. Appeal Procedure

Candidates who consider that their interests have been prejudiced by any decision related to the selection procedure can take the following actions:

8.1 Request for review of the decisions taken by the Selection Committee
