## The Authority

The European Banking Authority (“EBA”) is an independent European Union Authority established on 1 January 2011 by Regulation (EU) No. 1093/2010 of the European Parliament and of the Council of 24 November 2010.<sup>2</sup>

## The Mission

With a view to improving the functioning of the European Union internal market, the EBA contributes to ensuring a high quality, effective and consistent level of regulation and supervision in its areas of competence. It also promotes public values such as the stability of the financial system, the transparency of markets and financial products, and the protection of depositors and investors.

It works to prevent regulatory arbitrage and guarantee a level playing field, strengthens international supervisory coordination, promotes supervisory convergence and provides advice to the Union institutions in the areas of banking, payments and e-money regulation and supervision, and related corporate governance, auditing and financial reporting issues.

As an integral part of the European System of Financial Supervision (ESFS), the EBA works closely together with her sister authorities, the European Insurance and Occupational Pensions Authority (EIOPA) and the European Securities Market Authorities (ESMA), as well as the Joint Committee and the European Systemic Risk Board (ESRB).

The European Banking Authority is inviting applications to establish a reserve list for the position of IT Project Manager in the area of Project Management, Vendor Management, Budget and Contract Management for projects in the Information Technology Unit of the Operations Department.

## Job description

### Main purpose

Under the overall responsibility of the Head of IT Unit, the Project Manager would be responsible for managing EBA's critical projects and related resources according to the EBA Work Program and the IT strategy.

### Main responsibilities:

- Managing IT Projects in accordance with the project methodology and procedures of EBA;
- Managing resources involved in Projects, including contracting Vendors, planning, monitoring and controlling consumption of resources, managing and controlling associated budgets;
- Acting as development manager for IT projects that internally manage delivery of new IT Software Solutions or Services;
- Collaborate and communicate at all levels in the organization to drive appropriate awareness, information dissemination and resource planning and commitment for all activities in the lifetime of the project to ensure meaningful stakeholder engagement, user buy-in and overall successful delivery of Projects;
- Advocating for projects and project culture, providing trainings on Project Management, engaging stakeholders and communicating at all levels in the organization in order to continuously improve the Agency's ability to Execute through Projects;
- Acting as contact point and Subject Matter Expert for EBA's constituents (National Authorities) and peers in the areas of IT Projects and Programs, actively seeking and leveraging synergies and improvement opportunities, representing EBA in those fora.

## Requirements

### 1. Eligibility Criteria

To be considered eligible, candidates must satisfy all the criteria listed below, by the deadline for submitting applications.

## 1.1 General

- Be a national of a Member State of the European Union<sup>3</sup>, or a national of the European Economic Area (Iceland, Liechtenstein, Norway);
- Be entitled to his/her full rights as a citizen;<sup>4</sup>
- Have fulfilled any obligations imposed by the applicable laws on military service;
- Have a thorough knowledge of one of the official languages of the European Union<sup>5</sup> and a satisfactory knowledge of another language of the European Union;
- Be physically fit to perform the duties linked to the post.<sup>6</sup>

## 1.2 Specific

### 1.2.1 Qualifications

To be eligible, a candidate must have

a) A level of education, which corresponds to completed university studies attested by a diploma<sup>7</sup> when the normal period of university education is at least three years, or

b) A level of education, which corresponds to, completed university studies attested by a diploma<sup>7</sup> when the normal period of university education is four years or more.

### 1.2.2 Professional experience

To qualify for the position a candidate must have at least 10 years (on the basis of 1.2.1 a), or at least 9 years (on the basis of 1.2.2 b) of relevant proven fulltime professional experience in the field of IT covered by the job description after completing the education as mentioned above, of which at least 5 years in a comparable position in the area of project management.

### 1.2.3 Knowledge of languages

For working purposes, as English is the working language of the EBA<sup>8</sup>, an excellent knowledge of the English language, both written and spoken, is required.<sup>9</sup>

Native English speakers will be tested to prove their second language skills, in accordance with section 1.1.

## 2. Selection criteria

In addition to the above, the following selection criteria will be used:

- Significant experience in IT project management utilising multiple methodologies, executing large projects (for longer than 1 year and with budget exceeding €2m);
- Certification in Project Management;
- Proven experience of managing IT Projects delivering internally built IT Solutions as well as IT Projects delivering Vendor-based COTS solutions;
- Proven experience in Contract and Vendor Management, Budgeting, Procurement/Sourcing, Product Management;
- Proven experience of successful project delivery in environments with strong governance, dealing with a wide range of stakeholders, especially experience in engaging with senior management in private or public sectors.

It would be advantageous for the candidate to have

- Experience with procurement in the public sector (preferably under European Commission's rules);
- Experience in roles linked to IT Development and/or Software Development Lifecycle.

Applications will be assessed based on the Eligibility and Selection criteria specified in parts 1 and 2.

For this position, the candidates are expected to fulfil the following competencies which may be assessed during interview:

- Strong sense of responsibility and planning;
- Disciplined, able to keep the highest standards of quality and ethics, aiming for the best possible outcome;
- Agile, flexible, creative, solution-oriented with a problem-solving attitude in order to overcome obstacles and deliver in a dynamic and evolving institutional environment;
- Team-oriented, empathic, natural cross-border engager, energizing and contaminating others;
- Ability to analyse complex information from a wide range of sources, consider options and propose/implement solutions/recommendations;
- Ability to work efficiently under time pressure;
- Excellent communication and inter-personal skills, excellent presentation and boardroom pitching;
- Being able to manage own workload and work without close supervision.

## 3. Equal opportunities

As a European Union Authority, the EBA will apply a policy of equal opportunities and will take care to avoid any form of discrimination in its recruitment procedures.

## 4. Selection procedure

The selection procedure will include the following:

4.1. The selection committee will be established. All the candidates invited to interviews shall be informed on the composition of the selection committee in the invitation to the interview.

4.2. The selection committee will analyse application documents (curriculum vitae, motivation letter, and eligibility criteria grid) of applicants with reference to the eligibility and selection criteria and will establish a shortlist. Short listed candidates may be invited to sit written tests.

Written tests will be done in English and will be related to the job and designed to test the ability to communicate in written English, knowledge and competencies related to the job, and drafting skills. Total mark for written test: 10. The minimum score to pass: 6.

**Only the candidates successful in written tests will be invited to interviews.**

Successful candidates with the total score equal to and above 12 will be placed on the reserve list, which will be valid until **31 December 2020**. It may be renewed. Inclusion in the reserve list does not guarantee recruitment. The successful candidate will be selected from the established reserve list which may also be used depending on the needs of the EBA.

In accordance with Articles 11 and 11a of the Staff Regulations (SR) and Articles 11 and 81 of the Conditions of Employment of Other Servants of the European Union (CEOS) **the successful candidate will be required to make a declaration of the conflict of interest before recruitment.** The EBA's Executive Director will examine whether the successful candidate has any personal interest which may impair his/her independence or any other conflict of interest in relation to the position offered and will adopt appropriate measures. To that end, the successful candidate, using a specific form shall inform the Executive Director of any actual or potential conflict of interest.

Please note that the selection committee's work and deliberations are strictly confidential and that any contact with its members is strictly forbidden. Any contact made by the candidates or third parties in order to influence the members of the selection committee in relation to the selection constitutes grounds for disqualification from the selection procedure.

## 5. Appointment and conditions of employment

### 5.1 Contract type, duration and starting date:

The successful candidate will be offered a temporary agent<sup>10</sup> fixed-term contract of three years with a probation period of nine months and the possibility of extension.

The estimated starting date is **1 December 2019**.

**Information reserved for candidates employed as temporary agents under Article 2 (f) of the CEOS in other EU agencies:** If the successful applicant from the external selection procedure is already a member of temporary staff 2(f) in another EU Agency, the relevant provisions of the Decision of the Management Board laying down general implementing provisions on the procedure governing the engagement and use of temporary staff under Article 2(f) of the Conditions of Employment of Other Servants of the European Union(EBA/DC/2015/126)<sup>11</sup> will apply.

## 5.2 Function group and grade:

The successful candidates shall be recruited as a temporary agent at grade AD 8. The estimated monthly basic salary is from € 6,934.02.

## 5.3 Summary of the conditions of employment

- Salaries are exempted from national tax; instead a Union tax at source is paid;
- The correction coefficient applicable to the remuneration of officials and other servants under Article 64 of the Staff Regulations for France shall apply;
- Depending on the individual family situation and the place of origin, staff members may be entitled to the following: expatriation allowance, household allowance, dependent child allowance, education allowance, installation allowance and reimbursement of removal costs, initial temporary daily subsistence allowance, and other benefits;
- Annual leave entitlement - two days per calendar month plus additional days for age, grade, and 2.5 days of supplementary home leave granted to staff entitled to the expatriation allowance or foreign residence allowance;
- EU Pension Scheme (after 10 years of service);
- EU Joint Sickness and Insurance Scheme, accident and occupational disease insurance coverage, unemployment and invalidity allowance;
- Travel insurance when travelling on missions.

## 6. Submission of Applications

Applications including a **curriculum vitae in the Europass format<sup>12</sup>, a motivation letter, and a filled eligibility criteria grid**, dated and signed should be submitted in English to the following address: [EBA-Applications@eba.europa.eu](mailto:EBA-Applications@eba.europa.eu) **by 16 September 2019 at 12.00 noon Paris time. EBA will disregard any application received after deadline. Applicants are strongly advised not to wait until the last day to submit their applications, since heavy internet traffic or fault with the internet connection could lead to difficulties in submission. The EBA cannot be held responsible for any delay due to such difficulties.

**Only complete applications will be accepted and considered.** In order for the application to be considered complete candidates must send all documents: curriculum vitae in the Europass format, motivation letter, and eligibility criteria grid dated and signed before the deadline.

Candidates should assess and check before submitting their application whether they fulfil all the requirements as specified in the vacancy notice, particularly in terms of qualifications and relevant professional experience.

Professional experience indicated in the curriculum vitae are counted only from the time the candidate obtained the certificate or diploma required for the position and if it is on paid basis (including study grants or internship grants) up to the closing date of applications. Start and end dates of all previous positions and whether full time or part time work should be indicated in the curriculum vitae. Candidates must be able to provide supporting documents clearly showing duration and nature of professional experience upon request.

PhDs may be counted as professional experience if the candidates received a study grant or salary during the time of PhD studies. The maximum duration counted for PhD is three years provided that the PhD has been successfully concluded by the closing date for applications of the selection procedure.

Freelance or self-employed candidates must provide either a copy of the entry in the relevant trade register, or any official document (for example a tax return document) showing clearly the length of the relevant professional experience. Details of any professional experience, training, research or studies must be given on the application form.

The address indicated in the curriculum vitae will be used as the location from which the candidates invited to interviews travel.

At this stage, please do not send supporting documents (copies of ID cards, passports, diplomas, etc.)

## 7. Data protection
