

# Data Protection Notice – Banking Stakeholder Group Call for Expression of Interest

# **Call for Expression of Interest**

The European Banking Authority (EBA) processes your personal data to co-ordinate the activities of the Banking Stakeholder Group (BSG). The EBA processes your personal data based on Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC with EEA relevance (EUDPR).

The following information is provided as established in Articles 15 and 16 of the EUDPR.

#### Who is the controller?

The EBA is the controller with regard to the data processing activities described in this data protection notice.

# What personal data do we process, for what purpose, who can access it and how long do we keep them?

Categories of persons whose data is processed (i.e. potential BSG members) in the context of the above-mentioned BSG Call for Expression of Interest:

- Members from financial institutions operating in the European Union includes individual representatives and representatives of associations currently employed by or acting on behalf of Union financial institutions, representing the diverse models and sizes of financial institutions and businesses, including, as appropriate, financial market practitioners, institutional investors and other financial institutions which themselves use financial services, such as credit intermediaries and creditors (including non-bank creditors), Payment Institutions, E-money institutions and Investment Firms.
- Employees' representatives includes associations, bodies, individuals, or others which represent the interest of employees and trade unions, which may be paid by their employer.



- Consumers includes representatives of consumer organisations or any natural person acting for purposes outside his trade, business, craft or profession, and with proven record of dealing with consumer issues.
- Users of banking services includes individuals and associations delivering services and advice to consumers, including other retail users of banking services and end users of banking products, but not providers of banking services.
- Representatives of small and medium-sized enterprises (SMEs) includes individuals employed by a SME relevant to financial institutions, or representatives of their organisations.
- Independent top-ranking academics includes individuals, which preferably hold a Ph.D. in finance, economics, law or other field relevant to financial services, or equivalent qualifications and a solid academic experience in a university or institute of higher education (e.g. professorship), have a strong publication record in the field of finance, economics, law and participation in international conferences and workshops

The following categories of personal data are processed in the context of the above-mentioned BSG Call for Expression of Interest: title; full name; address; telephone number; email address; nationality; Curriculum vitae containing any information provided by applicants, such as employment history, academic history, biographical information; photograph; type of membership sought; conflict of interest declaration; consent to revisit the application; confidentiality agreement.

Personal data will be processed for the following purposes:

- Call for expression of interest for membership in the BSG
- Selection of members of the BSG
- Establishment of a reserve list of candidates for potential appointments

Personal data is received via the EU Survey application (<u>privacy notice</u>) and stored internally in access-controlled EBA locations.

Your personal data can be accessed by: BSG co-ordinator at EBA, Head of Unit for Governance and External Affairs, administration support for Governance and External Affairs Unit. Personal data could also be accessible by European Commission IT Support. Names of applicants will be shared with relevant coordinators at EIOPA and ESMA. Some personal data of successful applicants is published on the EBA website (e.g. name, photograph and biographical details).

The EBA will keep the personal data of applicants processed for the above purposes for up to four years - after two years a new selection of BSG members or two-year renewal takes place. The personal data may be transferred as part of the information referred to in Articles 15 and 16 EUDPR. In the case of legal challenge, personal data will be stored until the matter concerned is resolved.



### Why do we process your personal data and under what legal basis?

Your personal data are processed for the abovementioned purposes which are linked to the appointment of BSG members and to supporting the continuous effective composition of the BSG as is necessary for the performance of the EBA's tasks. This is in line with Article 37 of the EBA's Founding Regulation<sup>1</sup> which provides for the composition and operation of the BSG. As such, the processing of your personal data by the EBA is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the EBA pursuant to Article 5(1)(a) of the EUDPR.

#### Will the processing of your personal data involve any transfer outside of the EU?

Your personal data is processed within the EU/EEA and will not leave that territory.

## What are your rights regarding your personal data?

You have the right of access to your personal data and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. We will consider your request, take a decision and communicate it to you. For more information, please see Articles 14 to 21, 23 and 24 EUDPR.

#### You have the right to lodge a complaint

If you have any remarks or complaints regarding the way we process your personal data, we invite you to contact the Data Protection Officer (DPO) of the EBA (see section on contact details below).

You have, in any case, the right to <u>lodge a complaint with the European Data Protection Supervisor</u>, our supervisory authority for data protection matters.
